**NPPC Pre-Hearing Brief**  
**On a Petition to Remove Generalized System of Preference Benefits from**  
**The Kingdom of Thailand**

**I. Introduction**

The National Pork Producers Council (NPPC) presents this brief in support of its petition to withdraw or limit Generalized System of Preferences (GSP) benefits from the Kingdom of Thailand (hereafter referred to as Thailand). The NPPC petition on withdrawal of Thai GSP benefits was submitted in response to a *Federal Register* Notice dated April 4, 2018, soliciting petitions on the withdrawal of GSP benefits from GSP beneficiary countries.

NPPC is a national association representing a federation of 42 state pork producer organizations and represents the federal and global interests of 60,000 U.S. pork operations. The U.S. pork industry is a major value-added enterprise in the agricultural economy and a significant contributor to the overall U.S. economy.

**II. Thailand is a Huge GSP Beneficiary**

Thailand is the second largest recipient of trade benefits under the U.S. GSP program. U.S. imports from Thailand under the GSP program were valued at \$4.2 billion in 2017, accounting for 13.5 percent of total U.S. imports under the program. The country is the largest recipient of U.S. GSP benefits in agricultural trade, with U.S. imports of Thai agricultural products under the GSP program totaling \$832 million in 2017. The U.S. GSP program has made a significant contribution to an overall Thai surplus of \$617 million in agricultural trade with the United States.

While being a major beneficiary of U.S. GSP benefits, Thailand also enjoys a large trade surplus with the United States. According to Commerce Department data, the United States had a deficit of \$20.35 billion in trade in goods with Thailand in 2017, making it one of the top 10 trade deficit countries in the world for the United States. Commerce data also indicate that the United States had a deficit in services trade with Thailand of \$600 million in 2016. Imports under the GSP program, which, as mentioned, totaled \$4.2 billion in 2017, made a significant contribution to our overall trade deficit with Thailand.

In short, Thailand is a nation that takes full advantage of U.S. special trade benefits provided under the GSP program, contributing significantly to its large trade surplus with the United States. It does so while imposing a completely unjustified *de facto* ban on imports of U.S. pork. President Trump has called for reciprocity in our trading relationship with other countries, but there is no reciprocity at all in our trading relationship with Thailand when it comes to pork.

### III. Thailand's Restrictions on U.S. Pork

#### *Ractopamine*

Ractopamine hydrochloride (ractopamine) is a feed ingredient approved for use in the United States for swine and beef cattle. In swine, it is used for increased rate of weight gain, feed efficiency and carcass leanness in finishing swine.

The U.S. Food and Drug Administration approved ractopamine for use in hogs in 1999 after carrying out extensive risk assessments. No adverse human health problems have been reported from consuming meat products from food animals fed ractopamine since its approval in 1999. More than 300 studies, as well as commercial use in more than 600 million pigs, confirm ractopamine as being safe for pork in the food chain.

Additionally, 25 other countries have approved the use of ractopamine in pork production, and an additional 75 countries permit the importation of pork that has been produced using ractopamine, even though it is not allowed to be fed in domestic herds.

The human safety of meat products derived from food animals fed ractopamine has been confirmed by the U.N.'s Food and Agricultural Organization and the World Health Organization's food standard-setting body the *Codex Alimentarius*. In addition, it has also been affirmed by 30 regulatory authorities globally, using stringent safety criteria for approval and standards establishment.

Despite the wealth of scientific assessments pointing to the safety of the product, Thailand has for several years maintained a ban on the importation of pork produced with ractopamine. Thailand's import ban on U.S. pork produced with ractopamine has nothing to do with science or food safety and everything to do with the Thai government's interest in protecting its pork industry.

The U.S. government and the U.S. private sector have had numerous discussions, dating back to 2010, with the Thai government on the need to lift the country's ractopamine ban. When the U.N.'s *Codex Alimentarius* recognized the safety of ractopamine in 2012, Thailand's Department of Livestock told the U.S. government it was working with other Thai agencies "to align Thai laws and regulations with the recent decision by *Codex*." Thailand also indicated in a submission to USTR in the same year its intention to establish a "maximum residue limit" (MRL) for ractopamine, in line with the new *Codex* standard.

Six years later, Thailand continues to maintain its ractopamine ban. Thai promises to take action to allow the import of pork produced with ractopamine were very clearly a delaying tactic. It is equally clear that the Thai government has no intention of adopting a *Codex*-consistent MRL for ractopamine anytime in the foreseeable future.

Thailand's ban on the import of pork produced with ractopamine is in clear violation of the WTO Agreement on Sanitary and Phytosanitary Measures (WTO SPS Agreement). Thailand's

ractopamine ban violates various provisions of Article 5 of the WTO SPS Agreement related to the establishment of SPS measures based on science-based risk assessments, or internationally established food safety standards.

#### *Ban on Uncooked Pork and Offal*

Thailand maintains a ban on the import of uncooked pork and all pork offal products from the United States. This ban can be confirmed by a review of the USDA Food Safety and Inspection Service Export Library. The import ban is inexplicable, particularly in light of the fact that Thailand appears to allow the import of uncooked pork and pork offal from other international suppliers, including the European Union, Australia, China and Brazil. The United States ships safe, wholesome and competitively priced pork to more than 100 countries around the world; there is absolutely no legitimate reason for Thailand to maintain an import ban on U.S. pork products.

#### *Import Permits and Fees*

The Thai Department of Livestock and Development rarely, if ever, grants import licenses for U.S. pork. The Thai government has never provided reasoning for the arbitrary import permit refusals.

Even in those rare circumstances where import permits have been granted, Thailand imposes different fee structures for domestic pork versus imported pork. The import permit fee for pork is 7 Baht per kilogram, currently equal to about \$220 per metric ton (MT) at the current exchange rate. Thailand argues that the fee is needed to cover the cost of health inspections for imported pork. (This fee does not pertain to imported pork back fat, casings and offal used for re-export.) However, the fee is far in excess of the cost of any legitimate inspection fee. Domestically produced pork in Thailand is assessed an inspection fee of only \$7.50 per MT.

Thailand's import licensing practices violate provisions of the WTO Agreement on Import Licensing Procedures related to discretionary licensing. Its excessive import permit fees are a clear violation of GATT Article VII, which requires that any import fees be limited to the approximate cost of port services and should not represent an indirect protection to importers.

#### **IV. Thailand is a Major Recipient of GSP Benefits**

As noted earlier in this brief, in 2017 Thailand was the second largest recipient of U.S. GSP benefits in the world. Thailand's top 10 exports to the United States under GSP include auto vehicle accessories (HTS 8708, \$298 million), waters (HTS 2202, \$232 million), air conditioners (HTS 8414, \$206 million), clothing and apparel accessories (HTS 4015, \$192 million), food preparations (2106, \$163 million), fruits and nuts, prepared and preserved (HTS 2008, \$127 million), electrical transformers (HTS 8504, \$119 million), polyacetals (HTS 3907, \$86 million), motorcycles (HTS 8711, \$86 million) and internal combustion engines (HTS 8408, \$84 million).

A full list of U.S. imports of Thai products under the GSP program in 2017 can be found in Appendix 1 of this brief.

As we also noted earlier in the brief, Thailand is the largest recipient of U.S. GSP benefits in agricultural trade, with U.S. imports of Thai agricultural products totaling \$832 million in 2017. Thailand's top 10 agricultural exports (HTS Chapters 1–24) to the United States under GSP in 2017 were waters (HTS 2202, \$232 million), food preparations (2106, \$163 million), fruits and nuts, prepared and preserved (HTS 2008, \$127 million), sauces and preparations (HTS 2103, \$65 million), sugar confectionary (HTS 1704 \$33 million), pasta (HTS 1902, \$32 million), dates, fresh or dried fruits (HTS 0804), vegetables, prepared and preserved, (\$16 million), sugars, NESOI (HTS 1702, \$15 million) and malt extracts (HTS 1901, \$12 million).

A full list of U.S. imports of Thai agricultural products under the GSP program in 2017 can be found in Appendix 2 of this brief.

We are strong supporters of the U.S. GSP program because it benefits U.S. businesses and consumers through tariff savings while also supporting U.S. development objectives through robust enforcement of the GSP eligibility criteria. It is our hope that all beneficiary countries will continue to make progress toward meeting the GSP eligibility criteria to maintain full participation.

But, as detailed above, Thailand has made little or no progress. For that reason, we urge the Office of the U.S. Trade Representative to consider whether it is appropriate to suspend some of Thailand's GSP benefits to ensure better compliance with the letter and spirit of the eligibility criteria.
